### REACH and SVHC-List

The last addition to the list of candidates took place on 15.01.2019; since this last update, 197 substances are on the candidate list. According to Article 33 of the REACH Regulation, an information obligation exists if an SVHC substance in a concentration above 0.1% by mass is included in the article. Our products do not contain substances on the candidate list in concentrations above 0.1% by mass.

Substances subject to authorization are listed in Annex XIV of the REACH Regulation. The latest addition to Annex XIV was made by the EU Commission with Regulation (EU) No 2017/999 (last update 25.07.2018). Our products do not contain any substances listed in Annex XIV.

With regard to the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), our products are free of substances within the specified limits, the use of which is restricted in accordance with Annex XVII.

Regulation (EC) No 1907/2006 does not give us any obligation to declare.
